CORRIGENDUM – NOTICE TO CANDIDATES

Reference Union Public Service Commission's Advertisement No. **03**, Item No. **27** published on **13.02.2010** with closing date of receipt of applications as **04.03.2010** (**11.03.2010** for applicants from abroad and to those posting applications from Andaman and Nicobar Islands, Lakshadweep, States in the North Eastern Region, J&K State, Sikkim, Pangi Sub-Division of Chamba, Lahual & Spiti Districts of Himachal Pradesh), for recruitment to Fifty eight (58) Posts of Principal (34 male & 24 female) in the Directorate of Education, Government of NCT of Delhi (Secretariat Education Department).
